WORKSHOP DESCRIPTION

The first week will focus on Theatre Games including building an ensemble as a group and engaging our imaginations through interactive play. The remaining classes will be theme-based while continuing to build confidence and skills using our actor tools: the body, the voice, and the imagination. Themes will include Under the Sea, Pirates, Wizards & Witches, and Broadway. Each week students will learn one short song and/or dance.
